

# Steele County CERT News 01-Aug-2024

#### June Severe Weather

The June rain and flooding had an impact across the County and Southern Minnesota. Within Steele County, about 20 residents reported some sort of impact. Steele County Emergency Management (SCEM) monitored flood gauge levels and assisted with activities across the County. SCEM accompanied representatives from the Federal Emergency Management Agency (FEMA), the Small Business Administration (SBA) and Owatonna on 17-Jul. The objective was to determine preliminary damages. The data is used to determine eligibility for support on a state-wide basis.

# **CPR Training**

The Train-the-Trainer course is available to CERT personnel who have completed CERT Basic Training and are interested in joining the ranks of trainers to teach the Basic Course for their CERT Program.

If you have an interest in being a qualified CERT trainer, an opportunity to participate in the CERT Train-the-Trainer course. The class will be held September 20 - 22 in St. Louis Park. The course is Friday evening, all-day Saturday, and all-day Sunday. Students must complete the full course to receive certification. A minimum class size is 8 and the maximum class size is 20.
